# WHY WE DO IT

Homelessness results when multiple oppressions intersect. Most notable are institutionalized racism and poverty. Although for women, homelessness may often be related to domestic violence, for undocumented immigrants to unlawful evictions, for poor families to gentrification and public housing cuts, for contingent workers to downsizing, for youth to child abuse, for gay or transgender people to social exclusion, for veterans to war trauma, for mentally and physically disabled people to inadequate health care and treatment.

The public view often sees homelessness as its own special category, unrelated to other categories of oppression. WRAP is working to change that perception and to organize a movement across categories of oppression as part of a united front that works towards human rights and social justice for all.
