

1,2,3 Instrucciones y Kit de Herramientas de Redes Sociales para Acción de Proteger Niños Sin Hogar

¡Llamando a todos nuestros aliados y sostenedores!

"¡Por favor, participa este martes 21 de enero (entre las 9 a.m. y las 5 p.m.) en una acción de 3 pasos para presionar al alcalde Daniel Lurie a garantizar que las familias salgan del refugio hacia viviendas y no hacia la calle!"

Contexto:

La falta de vivienda entre las familias en San Francisco se ha duplicado en los últimos dos años. 500 familias estaban en la lista de espera para refugio y la fila no avanzaba, los refugios y camas estaban llenas y no había viviendas disponibles. La ciudad

respondió en diciembre, eliminando a aproximadamente un tercio de las familias de la lista de espera para refugio, cambiando los criterios de elegibilidad de modo que ya no calificaban si vivían en hoteles o estaban duplicadas en otros hogares. Las familias dentro del refugio recibieron avisos de desalojo, la mayoría con fecha de salida para el 8 de febrero. Podrían calificar para extensiones, pero no se les informó cómo. ¡Las familias en los refugios están aterradas de ser enviadas a la calle y desesperadas por una vivienda! El próximo alcalde Lurie necesita escuchar fuerte y claro que las familias sin hogar deben ser una prioridad.

Tweet 1: @DanielLurie Family Homelessness has doubled in the last 2 years. Over a third of the 500 families on waitlist for shelter were kicked off for living in hotels or living doubled up. It's time to house families and make them a priority! #CribsNotConcrete #HouseSFKidsNow

Dear Daniel Lurie,

I'm emailing you today to urge you to ensure no families who have received shelter eviction notices end up on the streets, and to restore the family shelter waitlist. Homelessness among families in SF has doubled over the past two years. The city's response in December, which removed roughly a third of the 500 families from the shelter waitlist for living in hotels or doubling up, only exacerbated the problem.

To make matters worse, the almost 300 families currently residing in shelters have received eviction notices with mostly move out dates of February 8th and February 10th. While some may be eligible for extensions, they have not been informed on how to qualify, exposing the lack of coordination across agencies to adequately support and inform families. This process has caused further confusion and trauma for families.

Families facing homelessness need adequate support and pathways to permanent housing. The safety and well being of children and families must be our top priority. As our new mayor, your leadership is critical in addressing this urgent crisis. Our demands are the following:

- 1. Restore the waitlist in order to ensure families in hotels and families living doubled up are able to access shelter.
- 2. Employ a transparent process for families seeking shelter stay extensions, that provides adequate support and accurate information.
- Provide permanent housing solutions by adding 125 five year subsidies to the 125 being released in March and adding 50 flex pool subsidies to increase flow in the family shelter system. This will move most families off the waitlist, and move most families out of shelter into housing.

Thank you for your attention to this urgent matter. We urge that the city act with compassion and urgency to the growing homelessness crisis among families.


