

House Keys Not Handcuffs

Street Outreach Fact Sheet



9/23/2025

Members of the Western Regional Advocacy Project (WRAP) are conducting a street outreach initiative as part of our campaign to fight sweeps/displacement. This outreach keeps us accountable to the community as it captures the priorities, experiences and realities of our community members directly impacted by these inhumane practices.

Our country's long history of racist, classist policing extends its grip to the livelihood of our unhoused neighbors. When individuals share their experiences in our outreach, all do so only for the opportunity to speak *unfiltered* to the broader community about what is really happening to them. This is how we lay the foundation for a national organizing campaign and finally change the *narrative* of what a sweep actually is.

A "sweep" is widely misunderstood because we rarely hear from the people who are directly impacted by the brutality of destroyed belongings, forced displacement, worthless referrals with dead ends, and an ever growing list of hostilities. This is the purpose of our outreach initiative which seeks to uplift the experience of those enduring a sweep to better inform organizers and the broader public of needed solutions.

By identifying the common themes and trends across our 9 cities and 6 states, we can then speak truth to power. **Our outreach forms are available in [English](#) and [Spanish](#) and we invite you to join with us and do outreach in your community!!** Continue reading to understand the common trends we've identified about sweeps.



Of the 288 people we have spoken with so far:

When asked about advance notice of being sweep

- 71% reported No Advance Notice at All
- 55% reported being swept in the past 30 days
- 41% reported received 24 hour notice

When we asked how many people were impacted by the sweep

- 46% reported 6 or more people
- 28% were by themselves when swept
- 19% reported 2-3 people
- 16% reported 3-5 people



When asked what was the reason given for the sweep:

#1 response was “No reason given” #2 was “illegal camping” and #3 was “Trespassing/loitering”

Regarding people’s belongings:

- 85% reported Not being offered storage; when storage was offered, only 5 people got their belongings back in good condition
- 74% reported belongings thrown away at the time of the sweep

When asked who conducted the sweep:

- 78% of the responses said the police (74% Local / 4% State)
- 20% responded service provider or a private contractor (this is a growing trend)

And of those who were in a vehicle; 73% had their vehicle towed

When we asked how people were treated:

- 40% threatened with arrest
- 26% threatened with citation
- 22% had warrant checks run on them
- 19% reported some amount of verbal abuse

Where did people end up after being swept

- 77% ended up back living on the streets
- After being swept, 73% were given stay away orders.

When asked “what is important for the broader community to understand about sweeps;” the #1 answer was simply, “We are human.” The 2nd was “sweeps are traumatizing,” and lastly “we lose everything when we get swept.”

A full 90% of people felt they were targeted for being poor, with 45% identifying as “Disabled”

Last but not least; the big question of what alternatives/services people were offered

- 95% of people reported they were unable to access legal assistance
- 88% were not offered any type of service
- 80% of all referrals were **unsuccessful**
- Of the 17% of people who were offered services
- 7% were offered a shelter bed

“It’s not the Department of Homelessness, it’s the Department of Gaslighting.”
