Dear Mr. McNulty,

Requested were the counts of enforcements per statute for the following statutes: D.R.M.C. 38-86.2, D.R.M.C. 38-86.1, D.R.M.C. 38-115, D.R.M.C. 38-86, D.R.M.C.49-246, D.R.M.C. 39-3, D.R.M.C. 38-100, D.R.M.C. 54-548, D.R.M.C. 39-10, D.R.M.C. 38-175, D.R.M.C. 54-464, D.R.M.C. 54-465, and D.R.M.C. 54-466 from January 1, 2022, through March 31, 2024.

A breakout of the counts for each statute per month is attached. Counts are per statute enforced, not per incident.

Additionally, a separate breakout for D.R.M.C. 38-86.2 is attached due to additional steps needed for enforcement. Please know that the General Offense code for unauthorized camping was implemented in early 2023. Therefore, counts for these data points are unavailable until then.
